



Candidatures for the Presidency and for the Board of Ecsite 2015

How to apply

The Ecsite Board meets 3 times a year, once before the Ecsite Annual conference, once in November before the Directors' Forum and once in March. The composition of the current Board is presented on the next page. The **Presidency** of Ecsite and **seven Board trustees' positions are opened this year**.

The *Internal Regulations* describe the duties of the Board members and of the President. Candidates can apply, if they wish, for both the Presidency and for becoming a Board trustee. If candidates apply for both positions, two separate candidatures need to be sent with two different documents.

We invite each Full member interested in taking an active part in Ecsite and wishing to become candidate to the Ecsite Board or to its Presidency, to send its candidature **before April 6th 2015** to aurger@ecsite.eu

Candidatures for the Presidency

Candidates for the Presidency of Ecsite need to represent an institution Full member of Ecsite in 2015 and that is serving or has served on the Ecsite Board. The duration of the mandate of the President is of 2 years, then of another 2 years as Past President. The President cannot be re-elected for a second term. The President and the Past President sit on the Board of Ecsite and on the Executive Committee.

Candidates for the Presidency will be invited to meet and express their views to the Ecsite Board in Trento, on Tuesday June 9th at 16h00. Candidates for the Presidency will also present their views to the Full members during the Annual General Meeting (AGM), Wednesday June 10th between 14h00 and 17h30, when the election of the President by the Full members will take place.

The candidature should consist of **one document** in Word or PDF, should be on the letterhead of the institution and should include:

- Name of the institution, city and country
- Description of the institution
- Name of the designated Ecsite representative, position and short Curriculum vitae
- Statement expressing the views of the candidate for the Presidency of Ecsite for the two years of the mandate
- The document should be less than 1 Megabyte.

Candidatures for the Board of Ecsite, trustees

Candidates for the position of Board trustee need to represent an institution that is a Full member of Ecsite in 2015. The duration of the mandate of a trustee is of 2 years, renewable twice, for a maximum of six consecutive years on the Board.

The candidature should consist of **one document** in Word or PDF, should be on the letterhead of the institution and should include:

- Name of the institution, city and country
- Description of the institution
- Name of the designated Ecsite representative, position and short Curriculum vitae
- Motivation for the institution and its representative to become an Ecsite Board member
- The document should be less than 1 Megabyte.

Current Board members who are in election and who wish to run for the elections 2015 need to send their candidature under the same format and within the same deadlines.

Composition of the current Ecsite Board 2014-2015

The Ecsite Board is composed of **14** members including the President and the Past President.

Ecsite Presidency and seven Board Trustees positions are opened in 2015.

Some institutions elected in 2013 **can be re-elected** by the AGM 2015 if they submit their candidature.

Some institutions elected in 2013 have done 3 consecutive terms and **are not eligible** for re-elections.
