#### **Disclaimer**

Ecsite reserves the right to make changes in the location of a session due to organisational reasons.

Pre-Conference workshops are allocated on a strictly first-come, first-served basis. We reserve the right to cancel your place in your chosen Pre-Conference workshop if payment is not received on time. No registrations and no changes to Pre-Conference workshop registrations can be made after Wednesday 18 May 2022.

You may be photographed or filmed at the event and your image used in brochures, emails, films and on the Ecsite website. Should you not wish to have your image used, please contact the Ecsite team.

It is the delegate's own responsibility to carefully check the official regulations linked to the sanitary situation to leave their own country and to enter Germany prior to and at the time of the event. Please read our cancellation policy below carefully. Cancellation rules will be applied without exception for late cancellation due to a lack of respect or a lack of knowledge of official travel rules.

It is also the delegate's own responsibility to apply for and secure a Visa for entry into Germany if required. German law will apply in case of incidents.

In case of proven professional error/fault, the liability of Ecsite is limited to the withdrawal of the invoice. Any dispute arising from the execution of this invoice will be settled under Belgian law. The courts of law of the district of Brussels are exclusively competent to take cognisance of any possible disputes.

## **Cancellation Policy**

All cancellations must be made in writing to info@ecsite.eu.

- Between Wednesday 9 February and Wednesday 13 April 2022: free cancellation
- Between Thursday 14 April and Wednesday 18 May 2022: submitted to a charge of 50% of the fee
- After Wednesday 18 May 2022: no refund granted, and full payment is still due.

In case of no-show without written cancellation sent within above deadline, no refund will be granted, and full payment is still due.

Ecsite shall not be liable for any disruption either to the congress or attendees' travel arrangements due to force majeure events and no refunds will be made, either in part or full, for cancellations due to such circumstances. Circumstances amounting to force majeure include any event which could not be foreseen or forestalled, not even with all due care, including, but not limited to, war, threat of war, riot, civil strife, industrial dispute, terrorist activity, natural or nuclear disaster, fire, adverse weather conditions, volcanic ash clouds and all similar events.
