

Minutes of the Ecsite Annual General Meeting 2023

Friday, 16 June 2023 16:15 – 17:15 CEST

Republic Hall Mediterranean Conference Centre Old Hospital Street Valletta, VLT 1645, Malta

1. Welcome

Bruno Maquart, President of Ecsite, welcomes delegates to the 2023 Ecsite General Assembly Meeting, henceforth referred to in the minutes as the Annual General Meeting, or AGM.

2. Verification of the quorum and Opening of the Annual General Assembly Meeting

The meeting is declared quorate by Bruno Maquart with 64 of Ecsite's 213 Full Members with paid membership fees present or represented.

Bruno Maquart declares the Ecsite Annual General Assembly Meeting 2023 open at 16.38 CEST.

3. Designation of the Secretary of the Annual General Assembly Meeting

Bruno Maquart designates Nicola Hamilton of the Ecsite Head Office as Secretary of this AGM.

4. Election of the two 2023 Protocol Officers

Bruno Maquart suggests Lars Maroy, CEO VilVite - Bergen Science Centre, Bergen, Norway and Pilvi Kolk, Deputy Director, AHHAA Science Centre, Tartu, Estonia as Protocol Officers, who accept to be nominated for the role.

There are no further suggestions from the General Assembly on other names to be added to the list of Protocol Officers for the vote.

The General Assembly approves the 2023 Protocol Officers with 87 votes in favour, no votes against, and no abstentions.







5. Comments on the Minutes of the Annual General Meeting 2022 as approved by the 2022 Protocol Officers

Bruno Maquart invites the attendees to raise their comments on the 2022 AGM minutes 2022. There are no comments.

6. Activity report 2022

6.1 - Presentation of the Activity report 2022

Bruno Maquart begins with a review of the Ecsite activities in 2022 and early 2023. He explains that the Ecsite mission to connect, inspire and empower science engagement organisations and professionals has been guided by our compass in the 4 directions of the Ecsite strategic plan namely to confirm our leadership, to maximise our impact, to strengthen our community and to increase our sustainability.

Bruno Maquart details that stimulating new collaborations and creating new alliances with partners remains important to confirm and strengthen our position and our impact. Bruno Maquart points to the continuation of a series of meetings held with himself, Catherine Franche and various neighbouring networks and stakeholders, the detail of which can be found in the AGM booklet.

Ecsite continued to reinforce the importance of science engagement at various events during the presidency of the EU council. Bruno Maquart points to France in 2022 and Sweden in 2023, which have been particularly active and innovative to run symposiums and build bridges between science and society. Bruno Maquart references his speech at the Directors Forum in Amsterdam, where he called on each country holding the rotating presidency to seize the opportunity to put science engagement on the political agenda and thanks the Swedish Ecsite members for taking up this issue. Bruno Maquart congratulates the Spanish and Belgian Ecsite members for their proactivity in this matter for this end of year and beginning of 2024.

Bruno Maquart highlights that Ecsite has asserted <u>its global leadership</u> this year by pushing forward the agenda of the European science engagement field on an international level. This included initiating the International Directors Forum (IDF) which will take place together with the science engagement networks of ASPAC, ASTC, NAMES, RedPOP and SAASTEC at Heureka in Finland from 14 to 17 November 2023.

Bruno Maquart explains that in 2022, Ecsite involved 40 members from 20 countries in 9 projects funded under H2020 and Horizon Europe. Through these projects Ecsite advances the field and provides to the members involved the opportunity to develop resources and fruitful collaborations. Ecsite also secured 2 additional new EU funded projects, CleverFood and STEAM learning Ecologies in 2022.

Bruno Maquart points to the Ecsite Environmental Emergency Action which was initiated at the Directors Forum designed to encourage change in Ecsite members' own activities and increase their societal impact.

Additionally, Bruno Maquart highlights that Ecsite continued convening bi-monthly meetings with national European science engagement networks. He mentioned the 2022 Ecsite conference which took place in Heilbronn hosted by experimenta Science Center, and saw the introduction of a new members onboarding event.

Bruno Maquart indicates that the Winners of the Mariano Gago Ecsite Awards continue to inspire Ecsite community. He emphasizes the networks solidarity with Ukraine and the support provided to Ukrainian Ecsite members facilitating the provision of exhibitions.

Bruno Maguart refers to the monthly Spokes newsletter published by Ecsite for over 6000 readers.

Bruno Maquart announces that an agreement was signed with ASTC to join their data collection as a pilot initiative.







The 2023 Ecsite Conference saw the introduction of the CEO Focus event designed to facilitate the discussion of crucial issues among Ecsite senior leaders.

In 2022, and in 2023, Ecsite launched a wide range of initiatives, webinars, insights to support professionals and institutions in sharing practices and reaching their full potential.

Bruno Maquart refers to the sustainability of the Ecsite Conference stating it has been an important topic for several years. He questions that if climate crisis is one of the community's strategic commitments, how do we make sure that our annual meeting's negative impact on the environment is minimised? He states that recent hosts have introduced solutions to lower its carbon footprint and highlights the strides made in 2022 towards a more sustainable conference. Bruno Maquart thanks the strong collaboration of the experimenta team and explained that Ecsite initiated a donation made for each attendee to a tree planting scheme. Bruno Maquart indicates the network's ambition to continue this progress.

Bruno Maquart highlights the awareness of science engagement organisations on climate change and the loss of biodiversity and acknowledges the many initiatives they have taken. He states that as a network, we are aware of our societal and environmental responsibility confirmed by the launch of the Ecsite Environmental Emergency Action Plan. It was initiated at the Directors Forum in Amsterdam hosted by NEMO Science Museum with the objective of encouraging change in Ecsite members' own activities and increase our impact, being climate proof for our operations, facilities, and working methods.

Bruno Maquart emphasizes the importance placed on paying attention to the long-term balance between Ecsite's resources and expenditures in 2022 and that it is a constant concern. He states that the financial sustainability of our network is a challenge and should remain aware and open to innovative models too.

Bruno Maquart gives thanks to the Ecsite committees, Ecsite Board, the Conference Programme Committee, the Spokes editorial committee, the Mariano Gago Ecsite Awards Jury, the Space Group Steering committee. He reinforces that Ecsite would not be the same without their active participation.

To conclude, Bruno Maquart states that, while his presentation included activities that took place in the first half of 2023, participants are invited to vote only for the activity report that covers the year 2022.

6.2 - Questions

Bruno Maquart opens the opportunity to the floor for questions about the activity report. No questions or comments are raised.

6.3 - Vote on the Activity report 2022

The Activity report 2022 is accepted with 90 votes in favour, no votes against, and 1 abstention.

7. Financials 2022

7.1 - Presentation of the Accounts 2022

Kim Gladstone Herlev, Treasurer of Ecsite, presents the financial activity of Ecsite in 2022, as audited by DGST & Partners and detailed for Full Members in the AGM booklet. Kim Gladstone Herlev informs the attendees that this would be his last task as Treasurer due to the completion of his final term on the Board today.

Kim Gladstone Herlev outlines the Income and Costs for 2022 according to the three main categories. He notes that the three largest sources of income were the collaborative projects (43% vs 65% 2021), membership fees (19% vs 23% 2021) and the annual conference with business bistro (35% in 2022).







Kim Gladstone Herlev explains the collaborative projects income comes from EU projects as a reimbursement of eligible costs and the overheads covered a proportion of fixed costs. The AGM booklet shows Ecsite involved 40 members from 20 countries in 9 projects funded under Horizon 2020 (the European Commission's framework for research and innovation).

Kim Gladstone Herlev confirms the 2022 membership income was as expected invoicing €352.058 in membership fees. He stated the return to an In person Conference resulted in an Income from the Conference and Business Bistro of 35% of Ecsite's total result.

Kim Gladstone Herlev explains that Ecsite costs are all related to services to members, with the collaborative projects' personnel, head office and the annual conference as the three main 2022 costs. Together representing 90% (2021: 82%, 2020: 69%) of costs. The remaining costs by size: Facility costs, accounting/social and legal fees, taxes, sponsorship/fundraising, communication, Directors Forum and travel.

Kim Gladstone Herlev indicates 2022 was a normal situation and comparable in income and costs splits to 2019. He reminded that 2020 and 2021, because of the pandemic with no physical conference or business bistro and therefore no income from that source, resulted in a situation where the membership fees and collaborative projects became even more important than before.

Overall, in 2022, the <u>income</u> was €1.910.293 while <u>costs</u> amounted to €1.817.174 resulting in a positive <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of €93.119 and a positive overall <u>final result</u> of €69.880. Kim Gladstone Herlev highlights this is a very positive situation and that the <u>reserve</u> of Ecsite now amounts to €563.502 at the end of 2022.

Kim Gladstone Herlev explains the profile of the operating costs for the last 9 years supported by graphs. The difference (increase) in 2015 was caused by the provision made for the EC audit on three EU projects. The difference in 2020 was caused by the loss of income due to the pandemic with no physical conference and business bistro. In 2022 the loss of income was reversed into a positive result.

Kim Gladstone Herlev concludes by clarifying the reasons for the variations in Ecsite's reserve. From 2017 to 2019 Ecsite's reserve increased in line with EU advances on projects. Both are increasing now after two difficult years. The EU advances received on projects in 2021 was the highest seen at least during the last 7 years, and it is still high. In 2020 and 2021 the reserve went down but in 2022 it increased again as did the available part of the reserve.

7.2 - Questions

Bruno Maquart invites the floor to ask questions about the 2022 accounts. No questions are raised.

7.3 - Vote on the Accounts 2022

The General Assembly approves the Accounts 2022 with <u>80 votes in favour, 0 vote against, and 1</u> abstention.

7.4 - Vote on the discharge from the liability to the directors in office during the year 2022

In relation to the financial report 2022, Kim Gladstone Herlev further explains that the Belgian law governing companies and associations state that, after the approval of accounts, the General Assembly should vote on the discharge of the Directors who were in office during the financial year 2022. By this vote, the General Assembly gives up the possibility to hold responsible the directors for the financial decisions relevant to that year. He further reminds delegates that Ecsite's accounts are audited and the auditor gives a guarantee that the accounts give a true and fair view of Ecsite's equity and financial position in its report.

The General Assembly grants the discharge from liability of the Directors in office during the year 2022 with 76 votes in favour, no votes against, and 3 abstentions.







8. Financials 2023

8.1 - Presentation of the budget 2023

Kim Gladstone Herlev begins by remarking that the second post pandemic in person Conference, in Malta, explains the continued return of Conference income in the 2023 budget. This important source of income represents ¼ of the 2023 income. He states the budgeted income from the 2023 Conference is €26.000 less than presented at the 2022 AGM, due to reduced business bistro income.

Kim Gladstone Herlev shows increased income from 2 new EU projects, not budgeted at the last AGM.

The expected overall <u>income</u> for 2023 amounts to €2.058.500 which is €59.100 more than communicated last year.

In terms of <u>costs</u>, the overall costs are expected to be €2.028.000 which is €72.500 more than communicated during the 2022 AGM. This is due to the Board's decision to invest in the Ecsite Environmental Emergency Action and in the salary of one team member who returned to work at 50% after term long term sick leave.

The preliminary Budget 2023 shows a positive <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of €30.500 and positive <u>final result</u> of €1.000, meaning that the <u>reserve</u> will increase slightly to €564.502. Kim Gladstone Herlev ends by thanking Catherine Franche and the Ecsite team for a strong result despite many economic challenges.

8.2 - Questions

Bruno Maquart invites questions about the 2023 budget. No questions are raised.

8.3 - Vote on the budget 2023

The General Assembly approves the Budget 2023 with 80 votes in favour, no votes against, and 1 abstention.

9. Financials 2024

9.1 - Presentation of the budget 2024 and of the membership fees 2024

Budget 2024

Kim Gladstone Herlev begins by mentioning that the Budget 2024 will be approved by members at the next AGM in 2024. The preliminary overview of the main categories of <u>income</u> of €1.599.600 and <u>costs</u> of €1.652.800 showing a negative <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of €53.200 and a negative <u>final result</u> of €84.300. This corresponds to the salary of one staff member who came back in 2022 at Ecsite after a long sick leave to work on special projects and indicates a decrease in the reserve.

Membership fees 2024

Kim Gladstone Herlev notes that membership fees that will apply in 2024 must be approved by the General Assembly 2023.

Kim Gladstone Herlev explains that Article 3.5 of Ecsite's *Internal Regulations* stipulates that membership fees are indexed to the inflation rate of the Eurozone. In 2020, 2021 and 2022, due to the difficult financial situation of science engagement organisations the AGM, following the recommendation from the Board, chose not to apply the indexation. The result was membership fees which remained the same for three years: 2020, 2021 and 2022. In 2023 the fees were indexed and the proposal is to do the same for 2024.







Kim Gladstone Herlev quotes the European Central Bank which estimates inflation to average 2.9% in 2024 and recommends on behalf of the Ecsite Board to apply this indexation to the membership fees 2024.

9.2 - Questions

No questions are asked on the budget or the membership fees 2024.

9.3 - Vote on membership fees 2024

The membership fees 2024 are adopted with 74 votes in favour, 1 vote against, and 6 abstentions.

10. Election of the Ecsite President 2023 - 2025

Bruno Maquart hands over the chairing of the AGM to Herbert Münder, Past President of Ecsite.

Herbert Münder invites Bruno Maquart to give his presentation of his candidacy for his presidency.

Bruno Maquart stands for election and introduces himself and his organisation in front of the General Assembly.

As a result of the voting process, Universcience represented by Bruno Maquart is elected at the Ecsite Presidency with <u>75 votes in favour, 0 votes against, and 3 abstentions</u>.

Herbert Münder congratulates Bruno and hands back the chairing of the AGM to Bruno Maquart.

11. Election of the Ecsite Board of Trustees 2023-2025

Bruno thanks outgoing Board members – Ulrike Kastrup, Robert Firmhofer and Stephane Berghmans for their commitment, and ensures they will be missed.

In 2023, eight positions are open on the Ecsite Board. Positions are open for a 2-year mandate renewable twice, so 6 years in total. The candidates stand for election and introduce themselves and their organisation in front of the General Assembly.





As a result of the voting process, eight candidates are elected. Bruno Maquart therefore confirms the newly elected members of the Ecsite Board.
