

Minutes of the Ecsite Annual General Meeting 2022

Friday, 3 June 2022 15h45 – 17h00 CEST

The Ecsite Camp at Theresienwiese Auditorium Theresienstraße 74072, Heilbronn, Germany

1. Welcome

Bruno Maquart, President of Ecsite, welcomes delegates to the 2022 Ecsite General Assembly Meeting, henceforth referred to in the minutes as the Annual General Meeting, or AGM.

2. Verification of the quorum and Opening of the Annual General Assembly Meeting

The meeting is declared quorate by Bruno Maquart with 62 of Ecsite's 204 Full Members with paid membership fees present or represented.

Bruno Maquart declares the Ecsite Annual General Assembly Meeting 2022 open at 15:52 CEST.

3. Designation of the Secretary of the Annual General Assembly Meeting

Bruno Maquart designates Cristina Paca of the Ecsite Head Office as Secretary of this AGM.

4. Introduction and testing of the voting system

Andrew Whittington-Davis of the Ecsite Head Office explains the digital voting system, NemoVote, which is being used for the AGM.

5. Election of the two 2022 Protocol Officers

Bruno Maquart suggests Ursula Warnke (State Museum Nature and Man, Germany) and Peter de Haan (Museon-Omniversum, Netherlands) as Protocol Officers, who accept to be nominated for the role.

There are no further suggestions from the General Assembly on other names to be added to the list of Protocol Officers for the vote.

The General Assembly approves the 2022 Protocol Officers with <u>61 votes in favour, no votes against, and</u> <u>no abstentions</u>.

6. Comments on the Minutes of the Annual General Meeting 2021 as approved by the 2021 Protocol Officers

Bruno Maquart thanks the 2021 Protocol Officers and invites all participants to send comments by email regarding the Minutes 2021.

7. Activity report 2021

7.1 – Presentation of the Activity report 2021

Bruno Maquart begins by placing the activity report in the context of a year marked by a period of lockdown and progressive reopening of on-site activities, which required adaptations from Ecsite. He thanks the 313 Ecsite members for their crucial support and renewal of membership. He highlights a key milestone for Ecsite in 2021, the Ecsite Online Conference with 1,262 participants from 58 different countries, of which 42% were newcomers.

Bruno Maquart goes on to present further achievements according to the strategic directions defined in the Ecsite Strategy launched in 2021: 'Confirm our leadership', 'Maximise our impact', 'Strengthen our community' and 'Increase our sustainability'.

In terms of <u>confirming Ecsite's leadership</u>, Bruno Maquart points to regular meetings of the directors of the six international science engagement networks and, at the instigation of Ecsite, new bi-monthly meetings between the Presidents, Board representative and Directors of these networks and an International Directors' Forum that will take place in Europe in 2023. Moreover, Ecsite began a series of introductory meetings with European stakeholders from universities, academies, museums and with the European Commission: Science Europe, EUA – European University Association, NEMO - Network of European Museum Organisations, ALLEA – All European Academies, the Director General of DG Research & Innovation, ICOM Europe, and EUREC – European Network of Research Ethics Committees. During the Portuguese Presidency of the Council of the European Union, Ciência Viva organised in partnership with Ecsite a one-day hybrid conference. Furthermore, Ecsite joined the board of EUFIC (European Food Information Council) and the Advisory Board of the Horizon Europe's Ocean Mission. During this first semester of 2022, under the French Presidency of the Council of the European Valorisation Week and the Forum of Universities for the Future of Europe.

Concerning <u>maximising impact</u>, Bruno Maquart highlights the 13 EU-funded projects that involved 36 members from 24 countries in 2021 and five new proposals submitted for such funding. Additionally, bimonthly meetings took place with the national European science engagement networks. In 2023, the Ecsite Directors' Forum will be an International Directors Forum to be hosted by Heureka, the Finnish Science Centre, Finland, as decided by the Board.

As for <u>strengthening the community</u>, Bruno Maquart cites the six online professional learning Workrooms, the in-person 2021 Directors' Forum hosted in Paris by Universcience, EXTRA, the online market place for touring exhibitions, and the online activities of the Ecsite Space Group in collaboration with ESA - European Space Agency. He mentions that 2021 saw the launch of a new data collection project to share specific information that can benefit members. Lastly, he stresses that Ecsite stands together with Ukraine and Ukrainians.

Regarding <u>sustainability</u>, Bruno Maquart points to the change in format of Spokes, Ecsite's online magazine: Spokes Magazine became quarterly while Spokes News brought information to members in the months in between. Spokes and Ecsite's social media channels reach thousands of people connected to science engagement. Bruno Maquart reports that 2022 Annual Conference has also taken steps to be more sustainable, highlighting in particular the pilot attempt to offset the carbon footprint from travel by donating to reforestation efforts in the districts of Heilbronn. Bruno Maquart thanks the members of the different <u>committees</u> – the Board of Trustees, the Annual Conference Programme Committee, the Spokes

Editorial Committee, the Mariano Gago Ecsite Awards jury, and the Space Group Steering Group – for dedicating their time and resources to Ecsite. Lastly, Bruno Maquart mentions as a sustainability focus for the future an increase in sponsorship and funding for long-term projects.

To conclude, Bruno Maquart states that, while his presentation included activities that took place in the first half of 2022, participants are invited to vote only for the activity report that covers the year 2021.

7.2 – Questions

No questions or comments are raised.

7.3 - Vote on the Activity report 2021

The Activity report 2021 is accepted with 66 votes in favour, no votes against, and no abstentions.

8. Financials 2021

8.1 – Presentation of the Accounts 2021

Kim Gladstone Herlev, Treasurer of Ecsite, presents the financial activity of Ecsite in 2021, as audited by DGST & Partners and detailed for Full Members in the AGM booklet.

He outlines the Income and Costs for 2021 according to the main categories. He notes that the two <u>largest</u> <u>sources of income</u> were the collaborative projects (64,64%) and membership fees (23,37%), and that a small income was generated from the #EcsiteOnline events.

The two <u>largest categories of costs</u> were the Head Office and collaborative projects, together amounting to around 82% of all costs. Costs for further services to members include the #EcsiteOnline events, facilities costs, accounting and social and legal fees, taxes, communication, sponsorship and fundraising, the Directors' Forum and travel.

Comparing this overview with that of past years, Kim Gladstone Herlev remarks that the Annual Conference and its Business Bistro are no longer among the most important sources of income and costs due to the fact that the Annual Conference could not be held in person in 2020 and 2021 as a result of the COVID-19 pandemic. This has led to a situation where membership fees and collaborative projects become more important than before in terms of income.

Overall, in 2021, the <u>income</u> was $\in 1.526.669$ while <u>costs</u> amounted to $\in 1.544.450$ resulting in a negative <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of - $\in 17.780$ and a negative overall <u>final result</u> of - $\in 39.393$. Kim Gladstone Herlev highlights the fact that compared with the Budget 2021 approved at the 2021 AGM, this represents a positive difference of $\in 129.819$ and that the <u>reserve of Ecsite</u> remains positive overall, amounting to $\in 493.621$ at the end of 2021.

Kim Gladstone Herlev concludes by outlining that in 2021 Ecsite managed to reduce the loss of income experienced due to the COVID-19 pandemic and that, while the reserve of Ecsite decreased in 2020 and 2021, it remains at a higher level than in 2016.

8.2 – Questions

No questions are raised.

8.3 – Vote on the Accounts 2021

The General Assembly approves the Accounts 2021 with <u>69 votes in favour, 1 vote against, and no abstentions</u>.

8.4 - Vote on the discharge from the liability to the directors in office during the year 2021

In relation to the financial report 2021, Kim Gladstone Herlev further explains that the Belgian law governing companies and associations state that, after the approval of accounts, the General Assembly should vote on the discharge of the Directors who were in office during the financial year 2021. By this vote, the General Assembly gives up the possibility to hold responsible the directors for the financial decisions relevant to that year. He further reminds delegates that Ecsite's accounts are audited and the auditor gives a guarantee that the accounts give a true and fair view of Ecsite's equity and financial position in its report.

The General Assembly grants the discharge from liability of the Directors with <u>68 votes in favour, no votes</u> <u>against, and no abstentions</u>.

9. Financials 2022

9.1 – Presentation of the budget 2022

Kim Gladstone Herlev begins by remarking that the Budget 2022 was prepared on the assumption that it would be possible to organise an in-person Annual Conference in 2022 and this proved to be correct. Therefore, the Budget 2022 sees the return of the Annual Conference and its Business Bistro as an important source of both income and costs, with the financial overview beginning to resemble that seen before the COVID-19 pandemic.

The expected overall <u>income</u> for 2022 amounts to €1.980.300, which is €278.900 more than communicated at the AGM 2021. This is in part because of a higher number of participants at the Annual Conference, higher membership fees invoiced, and higher income from collaborative projects than anticipated in 2021.

A similar development is noticeable in terms of <u>costs</u>, with overall costs anticipated at €1.923.300, which is €260.700 more than communicated at the AGM 2021. The three main categories of costs are expected to be collaborative projects, the Head Office, and the Annual Conference and its Business Bistro.

The preliminary Budget 2022 shows a positive <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of \in 57.000 and positive <u>final result</u> of \in 40.100, meaning that the <u>reserve</u> will increase slightly to reach \in 533.721. Kim Gladstone Herlev ends by thanking the Ecsite Head Office for the financial management that has led to this positive news.

9.2 – Questions

No questions are raised.

9.3 – Vote on the budget 2022

The General Assembly approves the Budget 2022 with <u>71 votes in favour, no votes against, and no abstentions</u>.

10. Financials 2023

10.1 – Presentation of the budget 2023 and of the membership fees 2023

Budget 2023

Kim Gladstone Herlev begins by mentioning that the Budget 2023 will be approved by members at the next AGM in 2023. The preliminary overview of the main categories of <u>income</u> and <u>costs</u> for 2023 resembles that seen before the COVID-19 pandemic. The preliminary final outcome of a positive <u>EBITDA</u> (earnings before interest, taxes, depreciation, and amortization) of \in 43.900 and positive <u>final result</u> of \in 12.300 sends an important message. The reserve of Ecsite will be maintained and slightly increased.

Membership fees 2023

Kim Gladstone Herlev explains that Article 3.5 of Ecsite's *Internal Regulations* stipulates that membership fees are indexed to the inflation rate of the Eurozone. Considering the difficult financial situation of science engagement organisations over the last three years, the General Assembly chose not to apply this indexation, upon the recommendation of the Board. This meant that membership fees remained the same between 2020 and 2022. At the same time, under Belgian rules, the personnel costs of the Head Office were automatically indexed.

Kim Gladstone Herlev quotes the European Central Bank which estimates inflation to average 5.1% in 2022 and 2.1% in 2023. Considering the inflation costs born between 2020 and 2022, the Board of Ecsite recommends to apply the indexation rate of 2022, 5.1%, to the current fees. Kim Gladstone Herlev concludes by mentioning that applying the indexation of 5,1% instead of that of 2.1% does not represent a significant change for members, the difference ranging between ≤ 20 and ≤ 98 depending on the type of organisation they are.

10.2 – Questions

No questions are asked on the budget or the membership fees 2023.

10.3 – Vote on membership fees 2023

The membership fees 2023 are adopted with 61 votes in favour, 5 votes against, and 5 abstentions.
