

Call for Ecsite members to join H2020 project ROLES as Linked Third Party

About the project

ROLES responds to the call <u>Open Schooling and collaboration on science education</u>. The project's mission is to create a framework to facilitate the equal collaboration between actors from the learning ecosystems to build new learning pathways for learners with the outcome of making a change in their local community. Learning ecosystems feature partnerships between formal and non-formal education, government, business and community. Such systems go beyond education confined in a school setting and promote holistic and lifelong competences through integrating and respecting the wide range of experiences that contribute to bringing learning to life. Each of the local pilots will engage young people in different parts of their everyday life and in different settings of their environments to address local issues related to the <u>European Green Deal</u> and make a meaningful impact in their communities. The project will be implemented across 10 countries. To make the project results sustainable and long-lasting partners and third parties will be equipped with tools to keep these partnerships alive after the life of the project.

Role of a Third Party

Ecsite will involve 6 of its member institutions as Linked Third Parties in the project to do the following:

- To become a learning ecosystem coordinator.
- To develop the connections between schools, students, families, industries, CSO's and other organisations within their local community.
- To implement the ROLES learning framework to develop new interdisciplinary learning pathways and activities linked to the European Green Deal addressing local challenges.
- To engage a number of schools, companies, and other organisations that will run the activities;
- To be trained in the ROLES methodology and tools and attend 3 project meetings
- Provide detailed reports and insights on all activities as required by Ecsite.
- To disseminate the project in your country.

Criteria for selection: obligatory

- Ecsite member status
- Interest in growing local collaborations with your learning ecosystem
- English speaking project manager
- The institution must be active in public engagement in science, have an interest on the European Green Deal and an existing network of schools;
- The institution must be located and carry out its activities in one of the following countries : Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, France, Germany, Greece, Hungary, Latvia, Lithuania, Luxembourg, Malta, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, Albania, Bosnia and Herzegovina, North Macedonia, Iceland, Liechtenstein, Moldova, Montenegro, Norway, Serbia, Switzerland and Turkey

Criteria for selection: desirable



- Strong network of schools' and links with local companies, policy-makers, civil society organisations
- Demonstrable experience in public engagement on any of the topics of the European Green Deal
- Experience in co-design and co-creation activities

Indicative Budget

The budget will be calculated based on the Person month (one person working full time for one month) rate, including the following:

- An estimated 6 Person-months' salary
- Travel and subsistence for one staff member to attend three project meetings (€2.000)
- Budget for other direct costs including development and implementation of activities, meetings and any additional costs incurred in order to achieve the tasks outlined (€8.000)
- An additional lump sum as 25% for overheads
